

### **Title III EL Consortium Contract**

This agreement, made and concluded at Canton, Ohio, on July 1, 2026 by and between the Stark County Educational Service Center (SCESC), located at 6057 Strip Avenue NW North Canton, OH 44720 and the Coshocton City School District, located at 1207 Cambridge Rd Coshocton, OH 4312-2742.

Coshocton City is a public school district, organized under Chapter 33 of the Ohio Revised Code, engaged in the governmental function of providing educational services. SCESC is a third party entity engaged in providing educational services to Ohio school districts.

#### **Purpose of Contract:**

Coshocton City will receive a Title III Federal Grant allocation for the 2026-2027 school year. If the amount received is less than the required \$10,000 for the individual district to receive the allocation in their Title III English Learner grant, Coshocton City needs to be part of a consortium to utilize their allocation. If the amount received meets the required \$10,000 for the individual district to receive the allocation in their Title III English Learner grant Coshocton City may opt to participate in the SCESC Title III Consortium. This contract will establish the financial agreement between the Coshocton City School District and the SCESC. The Title III funding will be used for SCESC English Learner Consultant salary and fringe benefits. If available, a portion of the funds *may* be used by Coshocton City to purchase supplemental materials and supplies, professional development and/or family engagement activities, as agreed upon with the Coshocton City School District point of contact and the SCESC Title III Consortium Consultant.

#### **Term of Contract:**

The term of this contract shall be for July 1, 2026 through June 30, 2027.

The Coshocton City Schools has named a Title III Coordinator as their point of contact for requesting purchases and services. In the event that Title III Coordinator is unavailable, the Coshocton City School District Treasurer may be called for approval. Any other requests by Coshocton City staff, are to be directed to Title III Coordinator or the Coshocton City Treasurer.

The starting and ending times for services will be mutually agreed upon by Coshocton City and SCESC and subject to change depending on illnesses, weather conditions, school closings, holidays, and/or any other unforeseen events.

#### **Fees:**

Once the agreed upon portion of the allocation has been exhausted, it is the Coshocton City School District's responsibility to make supplemental purchases of materials and supplies.

#### **Payments:**

If the Coshocton City Schools exceeds their agreed upon portion of the Title III Consortium funds, they will be invoiced the additional amount.

#### **Qualifications and Services:**

SCESC Language Consultant(s)/Interpreter(s)/Translator(s) is/are required to uphold the ASHA Code of Ethics.

#### **Location of Services:**

Consultation services will be provided at the Coshocton City School District and SCESC.

**Amendments:**

All amendments shall be in writing and executed by both parties.

**Governing Law:**

This Agreement shall be governed by and construed under the laws of the State of Ohio. Venue for all actions brought to enforce the provisions of this Agreement shall be in Stark County, Ohio.
